Firewise Update: Structure Ignition Zone Assessments

The Glenlake Firewise team has been actively working with neighbors to improve wildfire resilience through Structure Ignition Zone (SIZ) Assessments. This summer, six Glenlake properties underwent in-depth evaluations based on the latest NFPA Firewise USA® and Home Ignition Zone (HIZ) standards.

These assessments review vegetation, building materials, and maintenance practices that may affect ignition risk, providing homeowners with practical, step-by-step mitigation plans. Each report highlights both current strengths and areas for improvement, with prioritized recommendations to reduce wildfire vulnerability.

Fire Station 47 Reopens Near Glenlake

At the end of July, fire crews officially returned to the newly renovated and expanded Fire Station 47, located just past our community entrance. This is a tremendous benefit for Glenlake, providing 24/7/365 fire protection and emergency medical response only seconds away.

The station is staffed around the clock by a four-person crew. Each firefighter is trained at the EMT-Basic Life Support (BLS) level, with Advanced Life Support (ALS) services available through an agreement with Austin/Travis County EMS. Per its service contract, Station 47 houses a Type 1 fire engine—the largest in size and water-pumping capacity—kept fully "response-ready" at all times. To ensure reliability in any situation, the station is also equipped with a 100kw emergency backup generator to power the entire facility.

We are fortunate to have this vital, life-saving resource right at our doorstep. Next time you see the Station 47 crews, be sure to wave and thank them for their dedication and service to our community.

911 Road Project

Water tower/tank construction is almost complete. The contractor for the Glenlake Pump Station Improvements work is in the last stages of this project. Remaining tasks include final electrical scope and programming, running a minor demolition, and restoration such as re-vegetation and concrete work. The contractor anticipates that overall, these items should take between one to two months to complete.

Area Updates

CONA Open House Recap

A big thank you to everyone who joined us on September 16 at the Karlin Innovation Center for the 2222 Coalition of Neighborhood Associations (CONA) Open House. The event brought together neighbors from across the Four Points area to learn about the proposed redevelopment of the former 3M campus, which includes plans for apartments, office space, and retail. Eight informational displays highlighted key topics such as traffic impacts, environmental protections, compliance with the Hill Country Roadway Ordinance, and potential intersection improvements from Bullock Hollow to City Park Road. Attendees also provided valuable feedback through our community survey, helping CONA better understand neighborhood priorities as Karlin's rezoning request advances.

Loop360 Project

The Loop 360 improvement project aims to eliminate stoplights along RM 360 from Highway 183 to Walsh Tarlton, easing congestion and improving traffic flow. This massive project is expected to take approximately 10 years to complete. For more details and project updates, visit TxDOT's Loop 360 Project page.

Current & Upcoming Phases:

Crews will set up the work zone to stabilize the upper limestone cliffs on the west side of Courtyard Drive adjacent to southbound Loop 360 mainlanes. An estimated 155,000 cubic yards will be excavated during this advance work for the Loop 360 at Courtyard Drive/RM 2222 project which is currently anticipated to start construction in mid-2026
